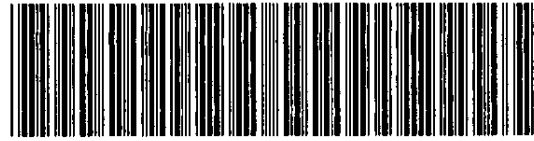

Sonoma Hills, Inc., a Florida corporation, bearing Document Number: P96000095590.




