This firm represents Haciendas-Pines Property Owners Association, Inc. In August 2021, we sent to the Division of Corporations an Amendment to the name of the corporation along with corporate reinstatement fees for the above reference entity. At the time, we understand that the two documents were separated and ultimately rejected by the State. We then had a telephone conversation in which you indicated that we should resubmit the documents directly to you so both could be processed at the same time.

While we understand that the name Haciendas-Pines Property Owners Association, Inc. is taken by another entity, that entity is essentially the same entity requesting the reinstatement. Unfortunately, at some point, rather than reinstating the entity, a representative of the Association filed a new entity for the corporation. Based on the foregoing and due to some potential legal claims, the Association has voted to amend the name of the administratively dissolved entity so that the original entity can be reinstated and then merged with the active Haciendas-Pines Property Owners Association, Inc. We request that the name change and reinstatement be processed simultaneously such that Pines-Haciendas Property Owners Association is the new name of the entity (Document #754776) and it is now again, an active corporation.


ARTICLE I
