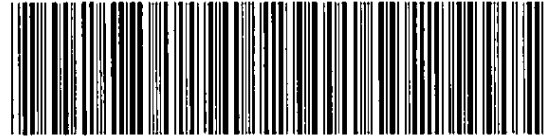

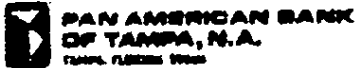

We, the undersigned, do hereby associate together and establish a corporation, not for profit, under the laws of the State of Florida.

ARTICLE 1

NAME

The name of the corporation shall be Florida High Schools Model United Nations, Inc., here after referred to as FHSUM, INC.. The office of the transaction of its customary business shall be CTR 2468, Tampa, Florida, 33620.

ARTICLE 2

PURPOSE

Section 1.

To promote better understanding and cooperation among the peoples of the world and for conducting joint promotional activities of common interest.

Section 2.

FHSUM, INC. is organized as a non-profit, educational organization within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 and as amended.

Section 3.

This corporation shall have no capital stock, its object and purpose being solely of a promotional character, and not for individual pecuniary gain or profit to its members.

Membership shall be open to all persons dedicated to the preservation of peace and security through global education without regard to race, sex, national origin, or religion, as outlined in the By-Laws.

ARTICLE 4

OFFICERS

The Officers of this organization shall consist of the Executive Council members: Secretary-General, Undersecretary-General, Executive Assistant, Financial Director, Conference Director, Publicity Director, and Financial Development Director.

ARTICLE 5

TERM

This corporation shall exist perpetually.

BOARD OF DIRECTORS


