

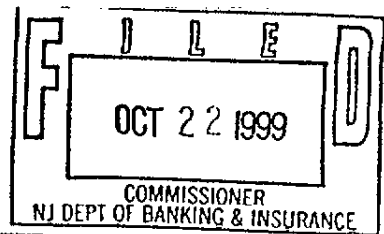

Pursuant to the provisions of Sections 17:26-1 *et seq.* of the New Jersey Statutes, the undersigned, The Camden Fire Insurance Association, a corporation organized under Sections 17:17-1 *et seq.* of the New Jersey Statutes, executes the following Certificate of Amendment to its Certificate of Incorporation:

1. The name of the Corporation is: The Camden Fire Insurance Association.
2. The following resolutions authorizing amendments to the Certificate of Incorporation were approved by the Board of Directors of the Corporation on the 2nd day of August, 1999:

RESOLVED: That Paragraph FIRST of the Certificate of Incorporation of this Corporation be amended so as to read in its entirety as follows:

FIRST: The name of this Corporation is CGU Insurance Company of New Jersey.

RESOLVED: That Paragraph SEVENTH of the Certificate of Incorporation of this Corporation be amended so as to read in its entirety as follows:

SEVENTH: A meeting of the stockholders shall be held at least annually, at a time and place to be designated from time to time by the Directors and stated in the notice of the meeting.

RESOLVED: That the Certificate of Incorporation of this Corporation, as amended by the amendments described in the foregoing resolutions, be restated in its entirety, and that the form of Restated Certificate of Incorporation of this Corporation attached hereto be and hereby is adopted and ratified.

RESOLVED: That the Board of Directors of this Corporation hereby declares the amendments described in the foregoing resolutions to be advisable, and that said amendments be submitted to the sole stockholder of this Corporation for consideration and approval.

3. The following resolutions approving amendments to the Certificate of Incorporation were duly adopted by the stockholders of the Corporation on the 2nd day of August, 1999:

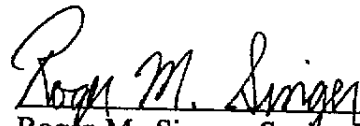

RESTATED CERTIFICATE OF INCORPORATION  
OF  
CGU INSURANCE COMPANY OF NEW JERSEY

THIS IS TO CERTIFY that the Amended Certificate of Incorporation of CGU Insurance Company of New Jersey, formerly known as The Camden Fire Insurance Association, is hereby restated as amended in its entirety to the end that such Restated Certificate of Incorporation should fully and completely set forth all the terms and conditions of the Certificate of Incorporation under which the Corporation shall hereafter transact business:

FIRST: The name of this Corporation is CGU Insurance Company of New Jersey.

SECOND: The location of the principal office of this Corporation in the State of New Jersey is 400 Fellowship Road, Mount Laurel, New Jersey 08054.

THIRD: The kinds of insurance proposed to be transacted by said Corporation are: Against direct or indirect loss or damage to property, including loss of use or occupancy, by fire, lightning, or tempest on land, being kinds of insurance authorized by Paragraph "A" of Section 17:17-1 of the revised statutes of New Jersey, and any other kind or kinds of insurance that may be proper subjects of insurance, except upon the lives of persons or the granting of annuities, as may be authorized by the Commissioner of Insurance pursuant to said Section 17:17-1 of the revised statutes of New Jersey.

FOURTH: The Corporation is to be a stock corporation.

FIFTH: The authorized capital stock of this Corporation is \$4,200,000 divided into 500,000 shares of a par value of \$8.40 each.

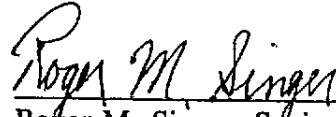
SIXTH: The period of the duration of the Corporation shall be unlimited.

SEVENTH: A meeting of the stockholders shall be held at least annually, at a time and place to be designated from time to time by the Directors and stated in the notice of the meeting.

EIGHTH: The Corporation shall have the power to classify policyholders and permit all or some of them to participate in the profits of the Corporation at such time and under such terms as the Board of Directors may determine.

NINTH: The Board of Directors shall be vested with the power to make and alter the By-Laws of the Corporation.

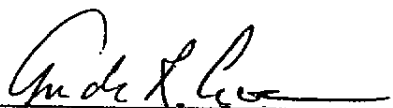


