Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act"), the following Articles of Merger are adopted by **20/20 IMAGING LLC**, a Florida limited liability company and **KONICA MINOLTA MEDICAL IMAGING, U.S.A., INC.**, a New Jersey corporation.

1. **Konica Minolta Medical Imaging, U.S.A., Inc.**, a New Jersey corporation, is the surviving entity ("Surviving Entity"). **20/20 IMAGING LLC**, a Florida limited liability company, the merging limited liability company, is a Florida limited liability company.
