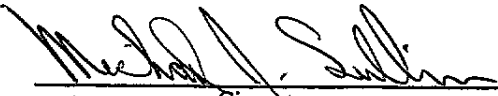

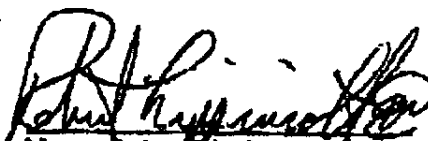
1. The name of the corporation (hereinafter called the "Corporation") is AXA Re Property and Casualty Insurance Company.
