CERTICFICATE OF AMENDMENT TO

THE CHARTER OF

AMERICAN INTERNATIONAL INSURANCE COMPANY

Under Section 805 of the Business Corporation Law and Section 1206 of the Insurance Law

We, the undersigned, Anthony J. DeSantis and Esta L. Cain, President and Secretary respectively of American International Insurance Company hereby certify as follows:

FIRST: The name of the corporation is American International Insurance Company.

SECOND: The Charter of the corporation was filed with the Insurance Department on September 19, 1985.

THIRD: The purpose of the Certificate of Amendment is to effectuate the corporation's name change from American International Insurance Company to 21st Century North America Insurance Company and change of domiciliary address from the County of New York, State of New York to the County of Nassau, State of New York.

FOURTH: The amendment effected by this certificate of amendment is as follows:

"1. The name of this company shall be 21st Century North America Insurance Company and its principal office shall be located in the County of Nassau, State of New York."

FIFTH: The Certificate of Amendment was adopted by Unanimous Written Consent of the Board of Directors of the corporation dated December 4, 2009.

SIXTH: The Certificate of Amendment was adopted by Unanimous Written Consent of the Shareholders dated December 4, 2009.

SEVENTH: The effective date of the Certificate of Amendment to the Charter shall be April 1, 2010.
