


I am writing to explain the late filing of the attached 2005 profit corporation annual report. I am the controller for Kamminga & Roodvoets, Inc. and therefore responsible for filing the corporate tax returns. On April 10<sup>th</sup> 2005 a married couple that I am personally dear friends with were killed in an automobile accident in Indiana. I am guardian of their three children that were in intensive care for several days due to the same automobile accident. I have just recently have returned to work and am trying to make sure that filings are taken care of and we realized that we missed the annual return in the process. We are filing as quickly as we could upon discovery of the oversight.

We believe that our history of filing timely combined with the circumstances described above would deserve consideration to waive the late penalty. Please feel free to contact me with any questions and thank you in advance for your consideration of the situation.
