This is with reference to the November 13, 2001 letter of intent (the "Letter") issued by the Comptroller of the State of Florida to approve Caja Madrid's application to establish an international bank agency in Miami, Florida. Pursuant to paragraph five of the Conditions Section of the Letter. enclosed is Caja Madrid's Application by Foreign Corporation for Authorization to Transact Business in Florida (the "Foreign Company Application"), as well as a check made out to the Florida Department of State in the amount of \$78.75.

As you know, Section 1 of the Foreign Company Application requires that Caja Madrid add to its name words indicating that it is a corporation instead of a natural person. However, the word "Caja" in Caja Madrid's name denotes that it is a savings bank under the laws of the Kingdom of Spain. To add Englishlanguage words, such as "Corporation" or "Incorporated," to Caja Madrid's name

for the purpose of qualifying to do business in Florida would be misleading and would result in Caja Madrid transacting business in Florida under a fictitious name.

Also, with reference to Section 11 of the Foreign Company Application, we have not attached a certificate of existence as the required certificate is on file with the Department.
