Based upon the information provided by this corporation, it is my recommendation that this file be closed. According to Harold N. Gosboll, Secretary of the Corporation, corporation applied for authority to conduct its affairs in Florida on April 28, 2003 and erroneously represented it has conduct its affairs in Florida since 1981. According Gosboll, whose affidavit is attached, the corporation's activities only consisted issuing charitable annuities out of California. Based upon the affidavit, it seems unlikely the corporation has conducted its affairs in Florida as defined in Section 617.1501, Florida Statutes. It is my opinion that outstanding fees and penalties are not actually owed. As a result, I recommend the Division's records should reflect corporation is qualified to conduct its affairs in Florida.


