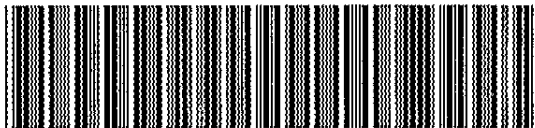

Dear Registrar,

During the course of filing our income tax return this year with the State of Florida, we were informed that we had to register "as a foreign profit corporation to transact business in Florida" and might be charged \$ 1,000.00 for not registering during 2002.

When we first started doing business in Florida 3/01/02, we registered for our sales and use tax certificate, payroll taxes and unemployment insurance. We began filing sales and use tax returns and started paying payroll tax per the information and instruction packets we received in the mail or downloaded off the Internet. During these processes, we spoke with numerous representatives from the Secretary of State Division in the State of Florida, and at no time did anyone mention to us that ADDITIONALLY, we needed to register as a foreign profit corporation to transact business in Florida.


We feel we jumped through every hoop presented to us during the course of setting ourselves up to do business in the State of Florida, and that we should not be penalized in any way financially. Had we known we had to register with this arm of the Division of Corporations in addition to the steps we had already taken, we certainly would have done it at the same time we registered for our Sales & Use Tax Certificate and Payroll Taxes. Due to this misunderstanding, we request that any late filing penalty fees be waived.

In addition, we are terminating our sole employee in Florida effective July 31, 2003, and closing our one-person office there on the same date. Please, if you ever make exceptions waiving penalties, we would greatly appreciate your consideration in our case considering all these factors.

Enclosed, you will find our Transmittal Letter, Application by Foreign Corporation for Authorization to Transact Business in Florida and an original certificate of existence not more than 90 days old from the State of Oregon.

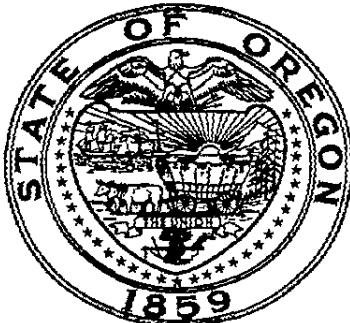


