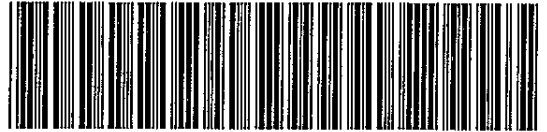

Dear Ms. Thomas:

I am writing on behalf of Kalkomey Enterprises, Inc. regarding the above referenced letter, a copy of which is attached. Kalkomey recently submitted the forms for qualifying to do business in Florida. On the forms Kalkomey reported the date that it began doing interstate business in Florida was 2001. It appears that as a result Kalkomey has been assessed penalty fees of \$2,300.


Kalkomey, which is headquartered in Dallas, Texas, does not now have and has never had employees or property located in Florida. It provides an educational program pursuant to a contract with the Florida Fish and Wildlife Conservation Commission (the Commission). The contract was accepted and signed by Kalkomey in Dallas, Texas. Pursuant to the contract, Kalkomey developed the instructional program at its Dallas headquarters. The Commission orders instructional books from Kalkomey. Orders are accepted in Dallas and payments are sent to Kalkomey in Dallas. In addition, Florida residents can access the instructional program online. The server on which the program resides is located in California, and Florida residents' payments for taking online certification tests are made online by credit card processed in Dallas, Texas. Test results are delivered to the Commission by uploading the information via the Internet from Kalkomey's Dallas headquarters into the Commission's database.

As you can see, Kalkomey's operations to date are a classic example of interstate commerce. As such, pursuant to sections 607.1501(2)(f) and (i) of the Florida Business Corporation Act, these activities do not constitute transacting business within the meaning of section 607.1501(1). Therefore Kalkomey has not heretofore been required

to qualify to do business in Florida and no penalties should now be assessed before it can qualify. Therefore I respectfully request that the forms be filed as submitted.

I understand from our telephone conversation that this letter will be submitted to your Legal Department for review. Please keep me informed of the progress in this matter.


