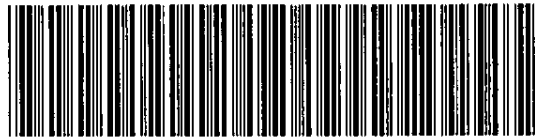

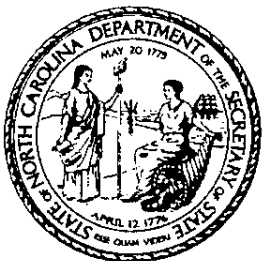

BUSINESS CORPORATION

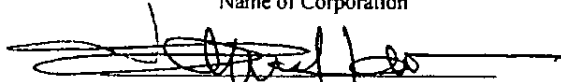
