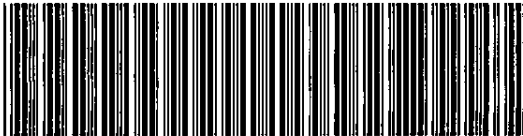

Per your request, this letter serves as verification that the State of Alaska is now issuing a document known as a Certificate Compliance, which is the State of Alaska's equivalent of a Certificate of Existence or Certificate of Good Standing. The paragraph below is taken from the State's webpage. When I tried to order a Certificate of Good Standing, the only item that is available is the Certificate of Compliance. I spoke with the State office and was told that the Certificate of Compliance is currently Alaska's document that is to be used for this purpose.

A Certificate of Good Standing, Certificate of Compliance and a Good Standing Certificate are names of certificates that have the same meaning. They show that the entity is in good standing or is in compliance with the State of Alaska Corporations Section. If you have been asked to provide a Certificate of Good Standing you can order this certificate online or by mail.

I hope this clarifies the State of Alaska's documentation.

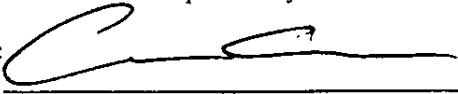
