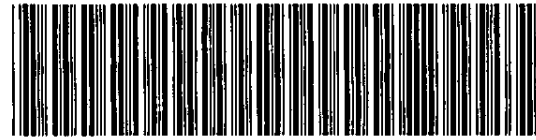

**CERTIFICATE OF AMENDMENT OF
CERTIFICATE OF INCORPORATION
OF GIGG, INC.
a Delaware corporation**

GIGG, INC., a corporation organized and existing under the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY THAT:

FIRST: The Corporation was originally incorporated on May 12, 2015 pursuant to the General Corporation Law of the State of Delaware and the Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on May 12, 2015 (the "Certificate of Incorporation");

SECOND: Pursuant to unanimous written consent of the board of directors of the Corporation dated January 30, 2016, the directors of the Corporation adopted resolutions approving and declaring advisable to amend the Certificate of Incorporation of the Corporation in order to (i) change the name of the Corporation to "Jobjet, Inc.," and (ii) to increase the aggregate number of shares which the Corporation shall have authority to issue to Twenty Million (20,000,000) shares of capital stock all of which shall be designated "Common Stock" and have a par value of \$0.0001 per share (the "Amendment");

THIRD: The Amendment was duly adopted and approved in accordance with the provisions of Section 228 of the Delaware General Corporation Law by the required vote of the stockholders of the Corporation pursuant to a written consent of the Stockholders of the Corporation; and

FOURTH: That the Amendment was duly adopted and approved in accordance with the provisions of Section 242 of the Delaware General Corporation Law;


RESOLVED, that the first paragraph of Article I of the Certificate of Incorporation be amended to read in its entirety as follows:

"The name of the corporation is Jobjet, Inc. (the "Corporation")."

RESOLVED, that the first paragraph of Article IV of the Certificate of Incorporation be amended to read in its entirety as follows:

"The aggregate number of shares which the Corporation shall have authority to issue is twenty million (20,000,000) shares of capital stock all of which shall be designated "Common Stock" and have a par value of \$0.0001 per share."
