This letter is in response to your letter dated October 3, 1995 to Mr. Thomas J. Tucci regarding the qualification of the above referenced entity in the state of Florida. I have attached a copy of your letter as well as our original application. Your letter states our application could not be accepted as filed and that the annual report and penalty fees applicable to Datatrend Technologies, Inc. ("Datatrend") are \$2,400.00. This letter responds to your letter of October 3, 1995.

Datatrend has a single employee who resides in the state of Florida. This employee works out of his personal residence. Our corporate headquarters and the remainder of our employees are all located in Minnesota. The Florida employee is an officer of Datatrend, primarily concerned with administrative tasks, but does provide sales support to Datatrend.

Datatrend does have some Florida customers, but the Florida employee is not primarily responsible for the Florida customers, or for that matter, any particular customer.

All customer calls are received and routed through our Minnesota facility. All orders, shipments, bookkeeping, and the like are handled in Minnesota. Simply stated, the move to Florida was a personal decision of the office, rather than a business decision for Datatrend.

The employee moved his residence from Minnesota to Florida in 1993. Datatrend provided the employee telephone, computer, fax, and other equipment necessary to keep the employee in contact with Datatrend headquarters. As mentioned, the employee works out of his personal residence.

During 1994, Datatrend and the Florida Department of Revenue exchanged correspondence, the result of which was a disagreement over whether Datatrend was required to file Florida income and intangible tax returns. When the Florida Department of Revenue made a final determination, Datatrend complied with the determination and filed the requested returns rather than appealing the determination of the Department of Revenue. However, based on our limited presence and activities, we did not and currently do not believe we are conducting business in Florida to a level requiring tax returns or qualification.

When we received the initial notice from the Florida Department of State, we once again acted to obtain qualification of our business even though our activities in Florida are minimal and still limited to a single, primarily administrative, employee.

Thus, while we will agree to obtain the certificate of authority in Florida, we feel that based upon our limited activities and presence and our efforts to date in attempting to comply as quickly as possible with Florida tax and business requirements, an abatement of the civil penalties proposed in your October 3, 1995 letter is warranted. Therefore, we ask that you abate all civil penalties and accept our application as originally filed.


