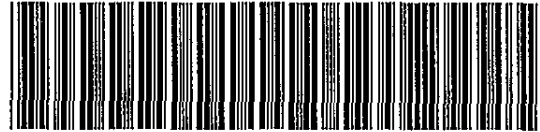

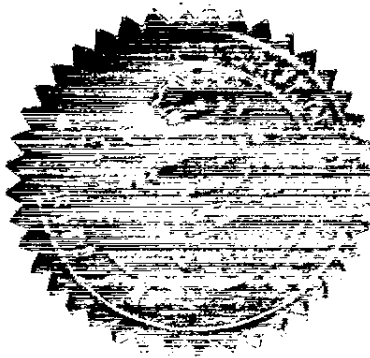

This is to certify that the Certificate of Incorporation of Predictive Business Decision Systems, Inc. (herein referred to as the "Corporation") which was filed and recorded with the Department of the Treasury of the State of New Jersey on August 14, 1993, and amended on December 7, 1996 and further amended on September 30, 1999, is hereby amended pursuant to the provisions of N.J. Stat. Ann. §14A:9-2 of the New Jersey Business Corporation Act.

ARTICLE I NAME OF CORPORATION

The name of the Corporation is Predictive Business Decision Systems, Inc.

ARTICLE II DATE OF ADOPTION AND TEXT OF AMENDMENT

The following amendment to the Certificate of Incorporation of the Corporation (the "Amendment") was adopted by the sole voting shareholder of the Corporation (the "Sole Voting Shareholder") pursuant to the Written Consent which was executed on February 5, 2008.

Paragraph 1 of the Corporation's Certificate of Incorporation is amended to read in its entirety as follows:

NAME OF CORPORATION

The name of the Corporation is PredictiveMetrics, Inc.

ARTICLE III APPROVAL OF AMENDMENTS

The Corporation has one thousand (1,000) shares of Common Stock consisting which consist of five hundred (500) shares of Non-Voting Common Stock and five hundred (500) shares of Voting Common Stock. The holder of the Voting Common Stock is entitled in vote to approve the Amendment. Pursuant to the Written Consent of the Sole Voting Shareholder, executed on February 5, 2008, the Sole Voting Shareholder approved the Amendment with five hundred (500) shares of Voting Common Stock voting in favor of the Amendment.
