As a way of introduction and explanation, I am the Business Manager for HUB. Mr. Herbert Bertrand reported to me. I apologize for not answering your letter of June 27th; however, it was not brought to my attention. In fact, Mr. Bertrand was dismissed in July and your letter was not in his current "To Do" files or in his desk. After several days of searching I have finally found it.

The date of first doing business in Florida is incorrect. November of 1995 is when we first had an employee doing business in Florida. And, at that time, we began reporting our sales taxes. I have no idea how Mr. Bertrand or Mr. Maples came up with October 1994 unless 94 was a typographical error. We moved our employee into Florida the last part of October 1995. His first payday was November 15, 1995.
