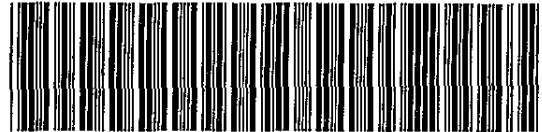

The Articles of Incorporation are amended as follows:


The existing ARTICLE III-Capital Stock is deleted and is replaced by the following:

IN WITNESS WHEREOF, the undersigned subscriber has executed this Amendment to Articles of Incorporation this 4th day of April, 2006.

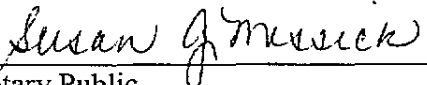
