

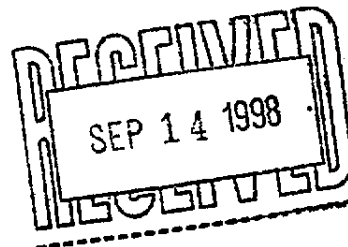

ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION

ARTICLE I.

NAME

The name of the corporation is HAAG & GAFFNEY, P. A.

ARTICLE VI.

PRINCIPAL OFFICE

DIRECTORS


The corporation is managed by a Board of Directors. The number of directors constituting the Board of Directors is two (2). The names and addresses of the directors are:




