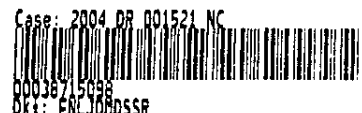


FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS MATTER, having been heard before the Court, is thereupon

ORDERED that:

1. The marriage between the Petitioner/Wife, REBECCA SUE NEWELL BLEVINS, and the Respondent/Husband, JOHN WILLIAM BLEVINS, JR., is dissolved because it is irretrievably broken.
2. The Marital Settlement Agreement between the parties dated February 13, 2004, the original of which is attached hereto as Exhibit "A," was voluntarily executed after full disclosure, and is approved and incorporated into this Final Judgment of Dissolution of Marriage by reference. The parties are ordered to comply with its terms. It is understood, however, that the Marital Settlement Agreement shall not merge with the Final Judgment of Dissolution of Marriage, but shall survive it.
3. The parties have agreed in their Marital Settlement Agreement that the Court shall retain jurisdiction in respect to various matters as provided in the Marital Settlement Agreement.
