The Limited Liability Company is to be managed by one or more Managers and the name and address of the currently appointed and serving Manager is:

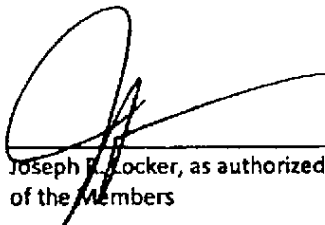
