The undersigned, who intends to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes, does hereby state and certify the following:

1. Name. The name of the Limited Liability Company shall be BELLE OAKS, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address of the principal office of the Limited Liability Company is 107 Herons Nest Lane, St. Augustine, Florida 32080.

4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent is Kathleen H. Cold, Lippes Mathias Wexler Friedman LLP, 10151 Deerwood Park Blvd., Bldg. 300, Suite 300, Jacksonville, Florida 32256.
