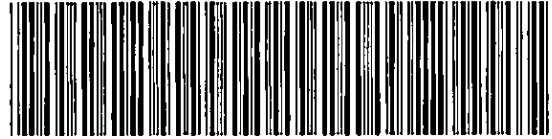

ARTICLES OF ORGANIZATION

ARTICLE I - NAME

The name of the limited liability company shall be **TIA'S, L.L.C.** ("Company").
