**ARTICLES OF ORGANIZATION

Jena, a natural person competent to contract and an authorized representative of Lot 18 Rolling Dunes Drive, LLC, hereby presents these Articles of Organization as the Articles of Organization of Lot 18 Rolling Dunes Drive, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is Lot 18 Rolling Dunes Drive, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:




