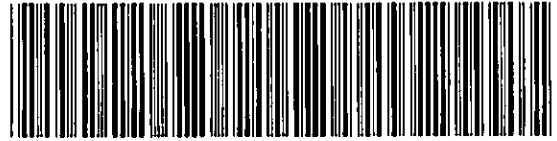

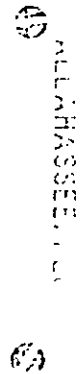

The name of the Limited Liability Company is "**F&I Acquisitions, LLC**" (the "**Company**").


**Article II.
