ARTICLES OF DISSOLUTION OF

Pursuant to the provisions of section 605.707, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

- FIRST:** The name and address of this Company is **AQUANETTI POOL TESTING SERVICES LLC**, 3750 Spring Crest Court, Lake Worth, Florida 33467.
- SECOND:** The Articles of Organization were filed on November 23, 2021 and assigned document number L21000499605.
- THIRD:** The date of the adoption of these Articles of Dissolution is 30 November 2021.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
