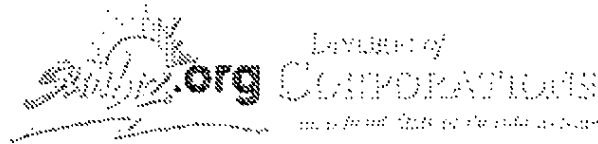

The name of the Limited Liability Company is HOUSE OF COINS, LLC.

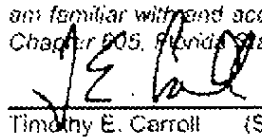
ARTICLE II - Address:
