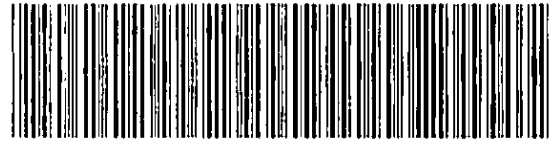

ARTICLES OF ORGANIZATION
OF
589 5TH AVENUE PARTNERS, LLC
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes and the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (collectively, the "Acts"), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be 589 5TH AVENUE PARTNERS, LLC, a Florida Limited Liability Company (the "Company").

ARTICLE II - ADDRESS

The mailing address of the initial principal office of the Company shall be 100 Kings Town Drive, Naples, FL 34102.

ARTICLE III - DURATION
