**ARTICLES OF ORGANIZATION
OF
ANGLIN PENSACOLA PROPERTIES LLC**

The undersigned, RYAN CAMPBELL, a natural person competent to contract and an authorized representative of ANGLIN PENSACOLA PROPERTIES LLC, hereby presents these Articles of Organization as the Articles of Organization of ANGLIN PENSACOLA PROPERTIES LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is ANGLIN PENSACOLA PROPERTIES LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
