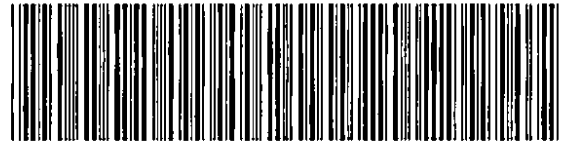

The mailing address and street address of the principal office of the Company shall be 5901 Turin Street, Coral Gables, Florida 33146.


**ARTICLE III. REGISTERED AGENT AND OFFICE**
