**ARTICLES OF ORGANIZATION

The undersigned, in forming a Florida limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Florida Act"), hereby adopts the following Articles of Organization:

1. Name. The name of the limited liability company shall be "THOUGHTBRIDGE LLC", a Florida limited liability company (the "Company").

2. Principal Office. The street and mailing address of the Company's principal office in the State of Florida are as follows:

5. Duration. The Company shall not have a specific effective date of dissolution, and its existence shall be perpetual in accordance with the terms and conditions of the Company's Operating Agreement.

6. Effectiveness. These Articles of Organization shall be effective as of the date registered by the Florida Department of State, Division of Corporations.
