Operating Agreement

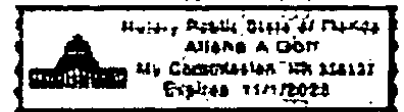

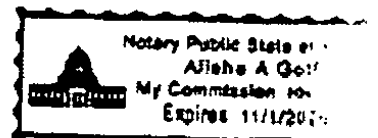
