ARTICLE 4 - DURATION

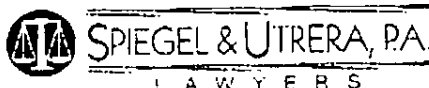

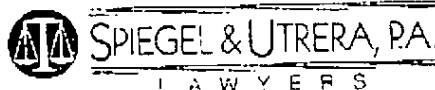
ARTICLE 9 - MANAGEMENT




