Article I
Name

The name of the limited liability company ("Company") is **WILD WEST, LLC**.

Article II
Address

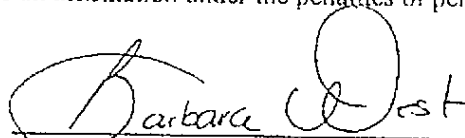

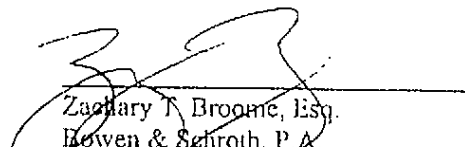
