**ARTICLES OF ORGANIZATION
OF
WIG LAKE CITY, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is WIG Lake City, LLC (the "Company"). The Company's principal address and mailing address is 204 37th Avenue North, Ste. 311, St. Petersburg, Florida 33704. The Company's initial registered agent is David M. 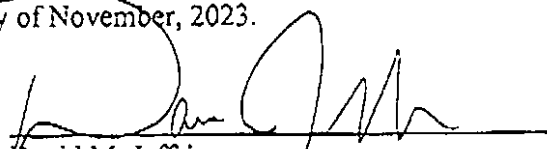

Indemnification

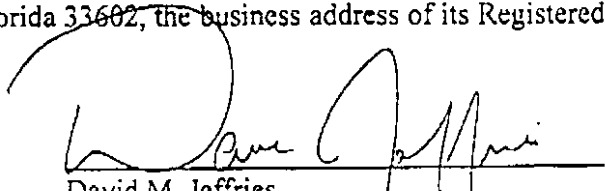

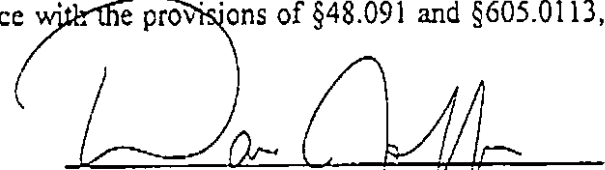
CERTIFICATE DESIGNATING REGISTERED AGENT
