

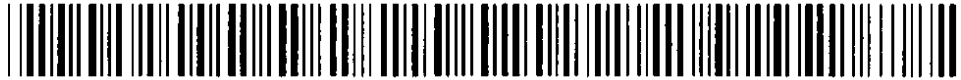

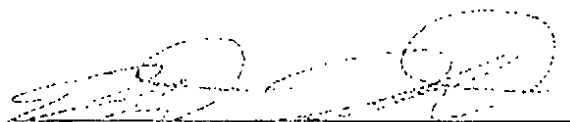
Article VIII
