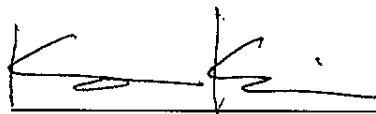
ARTICLE IV: EFFECTIVE DATE OF DISSOLUTION
