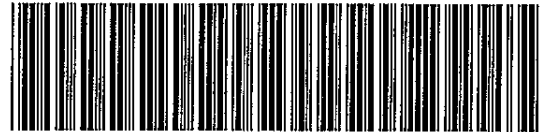



**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
PAINTER ASSOCIATES, INC.**

Under the provisions of F.S. 607.1006, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted: ARTICLE III. PURPOSE is being amended as follows:

The general nature and purposes of the business to be transacted, promoted and carried on by the corporation are marketing and related activities, and any and all other business and activities permitted by law.

The date of the amendment's adoption: July 1, 2004.


