**ARTICLES OF INCORPORATION**

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

**ARTICLE I NAME**

The name of the corporation shall be:

**Making Ministry Happen, Inc.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSE(S)**

The specific purpose(s) for which the corporation is organized is (are):

- A) This is a non-stock, non-profit organization applying for exemption under The Federal Tax Code 501C(3) as a charitable religious organization. The primary purpose is to make available information about fund raising methods (the How to Do It) that non-profit ministries and organizations may use to raise charitable funds. This information would be disseminated through manuals, videotapes and by in person or through phone consulting and coaching. A secondary purpose of this not for profit corporation is to help in being a catalyst for the Jesus video distribution to homes and individuals in selected areas.
- B) To exercise all rights and powers conferred by the laws of the state of Florida upon non-profit corporations.
- C) Provided, however, that the corporation shall not engage in any actions which are not permitted to be carried on by non-profit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensations to these people for services rendered, and to make payments and distributions to furtherance of its stated purposes.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The Bylaws shall provide the method of elections of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.


