

ARTICLE I
NAME

The name of this corporation is Moshiach Discovery Institute, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 7565 NW 44th Street, #1904, Lauderhill, FL 33319.

ARTICLE III
PURPOSE

The purpose of this corporation is to promote the study of Torah as the basis of the Jewish religion, with specific emphasis on the presence of Moshiach in the world. The corporation will be operating a Synagogue, conducting classes, counseling, performing charitable activities and observing Jewish holidays according to Jewish tradition.

ARTICLE IV
MANNER OF ELECTION OF DIRECTORS

A meeting shall be held for the purpose of electing an initial board of directors. Directors will be elected by a majority vote taken at said meeting.
