### ARTICLE I

The name of the Corporation is EAGLE AVENUE CHURCH OF CHRIST, EAGLE LAKE, FLORIDA, INC.

# ARTICLE II

The place of business is 551 Eagle Avenue, Eagle Lake, Florida 33839 and the mailing address of the Corporation is P.O. Box 117, Eagle Lake, Florida 33839. The effective date of this Corporation shall be DECEMBER 18, 2000.

# ARTICLE III

The specific purpose or purposes for which is the Corporation is organized, is spreading the Word of the Gospel, and the outreach to the community at large.

# ARTICLE IV

The congregation shall elect the Board of Trustees, which will consists of Five (5) members, who will be responsible for the conducting of any and all business in the name of the EAGLE AVENUE CHURCH OF CHRIST, EAGLE LAKE, FLORIDA, INC.

The Board of Trustees (Directors) shall appoint and designate committees to help in the daily operation of the Corporation.

The Board of Trustees shall have the responsibilty to appoint the pastor and missionaries and elders and to designate to any compensation, if any, to the minister missionaries, elders.

The Board of Trustees shall have the responsibility to appoint the Board of Deacons and other working committees of the Church who will work as voluntary workers and thus not eligible for monetary compensation.

The Board of Trustees (Directors) shall attend to the business of the Corporation and shall execute any legal documents necessary in the running of the Corporation.

The Board of Trustees (Directors) shall be the guarantor

of all funds and contributions received by the Church. Should the EAGLE AVENUE CHURCH OF CHRIST EAGLE LAKE, FLORIDA, INC, dissolve its corporation, the Board of Trustees (Directors) in any final liquidation of the Corporation shall have the right to determine all reimbursment and allotment of funds.

The Board of Trustees (Directors) may terminate any membership by vote of majority of the Board.

The membership of the EAGLE AVENUE CHURCH OF CHRIST, EAGLE LAKE FLORIDA, INC. has no vested rights in the real property of the Church.
