**A NOT FOR PROFIT CORPORATION**

We, the undersigned, desirous of forming a corporation not for profit, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

**ARTICLE I:**

The name of the corporation shall be MB AVIATION, INC. ("Corporation"). The principal place of business of this corporation shall be 35050 Dolphin Lake Drive, Zephyrhills, Florida 33541.

**ARTICLE II:**

The specific purpose for which this corporation is being organized is to own and operate general aviation aircraft as a lawful not-for-profit activity permitted under the laws of the State of Florida. The Corporation shall have no capital stock and the private property of the incorporators, officers, and directors, shall not be liable for the debts of the Corporation.
