**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SABAL PALM AT GRANDE OAK NEIGHBORHOOD ASSOCIATION, INC.

(a Florida Not-for-Profit Corporation)**

SABAL PALM AT GRANDE OAK NEIGHBORHOOD ASSOCIATION, INC, a Florida not-for-profit corporation organized and existing under the laws of the State of Florida, hereby certifies as follows:


Pursuant to written action of the Directors of the Corporation in lieu of a special meeting, the following Resolution was adopted on August 15, 2001, amending the Articles of Incorporation. No members of the Corporation were entitled to vote on the Amendment.


RESOLVED, that Article I of the Articles of Incorporation of the Corporation shall be amended, in its entirety, to read as follows:

The name of the corporation, hereinafter called the "Association," shall be Sabal Palm at Grandezza Neighborhood Association, Inc. Its principal place of business shall be at 9400 Gladiolous Drive, Suite 250, Fort Myers, Florida 33908. Its registered office shall be 5551 Ridgewood Drive, Suite #101, Naples, Florida 34108. The Board of Directors may from time to time move the principal office of the Association to any other address in the State of Florida.

WHEREUPON, on this 15th day of August, 2001, the Corporation has caused its President to execute these Articles of Amendment to the Articles of Incorporation that on the filing hereof, the Articles of Incorporation shall be deemed amended accordingly.
