ARTICLES OF INCORPORATION

The undersigned incorporation, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

Tabernacle By The Sea, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

We hereby associate ourselves together in like faith and beliefs for the purpose of constituting a church; to operate in accordance with the laws of God and in a non-profit corporate form pursuant to the applicable provisions of the statutes of the State of Florida relative to corporations not for profit; and hereby covenant and agree as follows:

1. To conduct services of a religious nature; to establish and maintain a place (or places) of worship.
2. To bring people to a personal relationship with Jesus Christ through the proclamation of the Gospel.
3. To proclaim and bear witness to all biblical truth.
4. To solicit funds, collect monies, receive gifts and bequests, and to otherwise raise money to supply for the maintenance and operation of the church and to fulfill the stated purposes.
5. To expend, contribute, disburse and otherwise handle and dispose of funds received for the proclamation of the Gospel of Jesus Christ.
6. To purchase, acquire, lease, rent, own, hold in trust, use, sell, convey, mortgage, or otherwise dispose of any real estate or chattels as may be necessary to hold in trust, properties for the stated purpose of Article II.
7. To borrow money, issue bonds, debentures, notes, or other obligations; secure for monies so borrowed or in payment for property, or any of the purposes stated under Article II.
8. To honor, worship, and glorify Jesus Christ.
9. To govern itself according to this constitution and by-laws adopted.
10. To establish and support bible colleges, church schools, and other churches should the opportunity present itself.
11. To establish and maintain such departments, institutions, and services for the propagation of the Gospel as needed.
12. To minister to the spiritual, financial, and physical needs of the community as the need may arise.

Believing in the independence of the local church, with full freedom of deliberation, decision, and deportment under God without restriction, supervision or domination from any outside individual, organization, or institution. This church is to be completely autonomous and self-governing and will not affiliate with any individual, organization, or institution, which seeks to exercise control over the local church. While maintaining its inherent rights of sovereignty in the conduct of its own affairs, this church shall voluntarily enter into spiritual fellowship with all churches of like precious faith.

The pastor, along with a majority (over 50%) of the membership, shall come together to choose the person or persons most capable and/or suitable for the office or offices to be filled within the church. The pastor will accept recommendations or nominations from the membership. Those chosen shall be appointed to such offices by the pastor, who shall describe and instruct the duties of that office or offices.

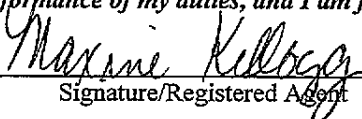
