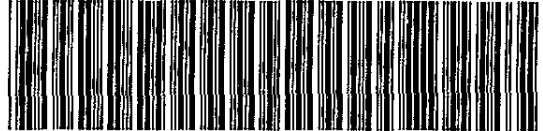

**ARTICLES OF INCORPORATION
of
PRELUDE CHAMBER MUSIC CAMP, INC.
A NONPROFIT ORGANIZATION**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I: The name of the corporation shall be Prelude Chamber Music Camp, Inc.

Article II: The Place in this state where the principal office of the Corporation is to be initially located is the City of Jacksonville, Duval County. 4770 Apache Avenue Jacksonville, FL 322

Article III:

- A. This corporation is organized exclusively for charitable and educational purposes for the benefit of the public and not for the private gain of any person. It is organized to qualify under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.**
- B. The specific purposes of this corporation are:**
 - 1. To support, develop, and promote new opportunities for music education in Northeast Florida.**
 - 2. To offer music students of all ages an opportunity to experience the special joy of participating in small ensembles with guidance and training provided by qualified consultants.**
 - 3. To organize and provide a venue for these ensembles to perform in the community.**

Our mission is to give musicians at every ability level an opportunity to experience chamber music in a positive and non-competitive way. We hope to inspire our participants to enjoy chamber music now as students and throughout their lives.

Article IV: The corporation shall have six directors who are elected yearly by a majority of the then current Board. The initial directors were elected at our organizational meeting on February 1, 2003. Their names and addresses are:

Article V: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

Article VI: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said Court shall determine, which are operated exclusively for such purposes.
