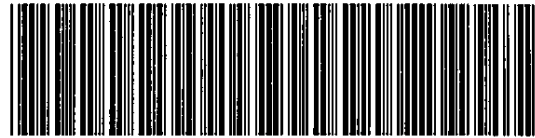



**SECOND:** The amendment was adopted by the Board of Directors and approved by 75% of members on the 24 day of October, 2006.

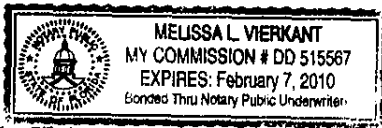
