ARTICLES OF INCORPORATION
OF
A&B MANAGEMENT OF PENSACOLA, INC.

I.

The name of the corporation is: A&B Management of Pensacola, Inc. (the "Corporation").

II.

The Corporation is organized pursuant to the Florida Not For Profit Corporation Act, as it may be amended from time to time [the Act].

III.

The principal place of business and mailing address of the Corporation is: P.O. Box 2837, Pensacola, Florida 32513.

IV.

The duration of the Corporation is perpetual.

V.

The name and the address of the initial registered agent and registered office of the Corporation is:

VI.

The purposes for which this corporation are organized are:

- (a) To conduct any and all charitable, religious, scientific or educational activities in furtherance of the spread of Christianity, giving special emphasis to the Christian view of life and the standard of ethics as set forth in the Holy Scriptures, and affirming basic truths of Christianity. All activities of this

corporation shall be consistent with the basic truths of Bible-based Christianity.

(b) Notwithstanding the foregoing, the corporation shall only conduct the following activities:

- (1) Disburse funds to charitable organizations approved by the Board of Directors; and
- (2) Engage in any lawful act or activity for which not for profit corporations may be organized under the laws of the State of Florida, including the management and maintenance of its intangible investments and the collection and distribution of the income from such investments or from its tangible property.

IX.

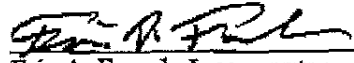
Except to the extent required by the Act, no director shall have personal liability to the Corporation or its members, if any, for monetary damages for breach of duty of care or other duty as a director. No repeal or amendment of this Article IX, nor the adoption of any Article inconsistent with this Article shall eliminate or reduce retroactively the effect of this Article. If the Act is amended hereafter to provide for further limitations on director's liability, then such further limitations shall be incorporated herein by reference, without the necessity of amending these Articles of Incorporation in order to list them.

The Corporation shall be managed, its affairs regulated, and indemnity provided to its members, officers and directors as provided in its Bylaws.

X

The Board of Directors shall have the power to alter, amend or repeal these Articles or adopt new Articles by an affirmative vote of all of the Directors then in office.
