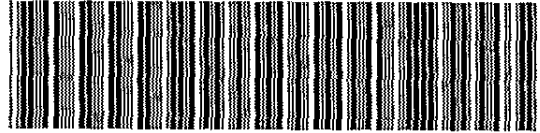

ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF  
THE 100 CLUB OF GULF COUNTY, INC.

Pursuant to the provisions of Section 617.1006, Fla. Stat., THE 100 CLUB OF GULF COUNTY, INC. hereby adopts this Amendment to its Articles of Incorporation for the purposes of changing a portion of Article II, and Article VII of the corporation. Such change shall be reflected as follows:

ARTICLE II

A. "Section 501 (C)" shall be amended to reflect  
"Section 501 (C) (3)"

B. The following language: "The primary purposes of this corporation is to provide benefits to certain eligible certified public safety employees of any federal, state, or local agencies, including public police, fire sheriffs department, public safety, or Department of Corrections employees and dependent children or family members of such employees" is deleted.

The remaining provisions in Article II shall remain unchanged.

ARTICLE VII

Each reference to "Section 501 (C)" shall be amended to reflect "Section 501 (C) (3)."

The remaining provisions in Articles VII shall remain


