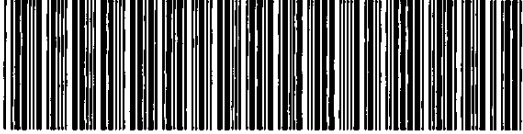

**ATTACHMENT TO THE
ARTICLES OF INCORPORATION**

OF

M.A. BALDWIN COMMUNITY OUTREACH MINISTRIES, INC.

a Florida Not-for-Profit Corporation

ARTICLE III. PURPOSE:

(a) This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(b) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(c) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

(d) In furtherance of the above stated charitable, religious, educational, and scientific purposes, purposes the corporation shall engage in community services and community outreach programs for the provision of comprehensive social service programs in an effort to provide a better quality of life to individuals within the community including but not limited to providing mentoring, tutoring, counseling and training for children, teens, young adults, parents and the elderly which may include day care, after school care, day camps, job readiness, employment and job placement, housing placement, social and personal well being training, drug counseling, programs for the discouragement of criminal behavior and truancy, parent training and sponsoring as well as the organization of comprehensive social, cultural, drama and sporting activities, events and programs to achieve the foregoing.
